1. Product Identification

Product type	Pre-penetrant etchant for aluminum alloys, gel form

2. Description and Application

Aluminum Etching Gel is a pre-penetrant etchant designed for aluminum alloys. The gel consistency prevents running on non-flat surfaces during application, so the product stays where it is placed throughout the etch.

It prepares aluminum parts for subsequent fluorescent penetrant inspection.

3. Composition

Sodium hydroxide (CAS 1310-73-2)	12 - 16 wt%
Balance	Deionized water and thickener

Concentration ranges are shown to protect formulation confidentiality and to allow for batch variation. Only hazardous components are listed.

4. Physical Properties

Appearance	Clear liquid gel
pH	> 14
Odor	No odor
Consistency	Viscous gel, similar to yogurt, stays in place on non-flat surfaces
Chemical stability	Stable under normal conditions of use and storage

5. Directions for Use

- Use only in a well-ventilated area with appropriate personal protective equipment.
- Apply the gel to the area being etched. It will stay in place on vertical and curved surfaces.
- Etch to the requirement of the governing specification or process sheet, then rinse thoroughly with water before penetrant inspection.
- Keep the container tightly closed when not in use.
