2. Description and Application

Class G is a chemical for etching high chromium superalloys and Inconel 718 as part of the pre-penetrant etch process in non-destructive testing (NDT), as outlined in multiple aerospace manuals such as GEK 9250.

It prepares these alloy components for subsequent fluorescent penetrant inspection.

3. Composition

Ferric chloride, hexahydrate (CAS 7791-13-1)	35 - 40 wt%
Hydrochloric acid (CAS 7647-01-0)	10 - 15 wt%
Balance	Deionized water

Concentration ranges are shown to protect formulation confidentiality and to allow for batch variation. Only hazardous components are listed.
